1. Purpose. To implement a revised date for disestablishment of subject shore activity per reference (a).
2. Background. This action revises disestablishment date for the Naval Station, Ingleside, TX. Disestablishment is as a result of a Base Realignment and Closure (BRAC) 2005 decision. Mine warfare commands and forces tenant upon the Naval Station will have transferred by 30 April 2010, terminating necessity for the Naval Station.
